**Posting of "This School Is A Zone of Peace" Banner**

1. The peace and order situation of the country has never spared our schools to be used as hiding places and even as battlefields where our personnel, teachers, students and pupils were caught in crossfire, taken as hostages, resulting to injury or even death and emotional and psychological trauma.
2. Along with this situation, all schools are hereby directed to put up a banner at a prominent location outside the school, preferably near the gate bearing the message, **"THIS SCHOOL IS A ZONE OF PEACE."** Old signages in some schools have to be refurbished.
3. Regional, Division, and District Offices, including all DepEd facilities will put banners with a slightly different message: **" EACH SCHOOL IS A ZONE OF PEACE. Hawak kamay tungo sa Kapayapaan."**
4. **Posting of banners shall not be later than October 10, 2013.** The standard size of the banner and other guidelines to follow, signed by Mario A. Deriquito, USEC for Partnerships and External Linkages, are attached in this Advisory.
