This Office would like to inform all concerned personnel that the Government Service Insurance System (GSIS) will resume the processing of the approval and release of the retirement/separation benefits of the DepED Personnel who have chosen to avail of the retirement/separation package under EO 366 s. 2004. To give those concerned a background of pertinent events, below is a timeline for your reference:

1. *March 03, 2014* - Following the issuance of Civil Service Commission Memorandum Circular No. 3 s. 2014, DepED requested for the temporary hold on the approval and release of the retirement/separation benefits of DepED personnel availing of the said option, pending the clarification on who are eligible to avail of the retirement/separation option under EO 366 s.2004;
2. *March 11, 2014* - As part of several consultations with the CSC and the Department of Budget and Management (DBM), a tripartite meeting among the three (3) agencies was convened to clarify matters;
3. *March 18, 2014* - DepED submitted the partial list of retiring/separating employees for approval of the DBM.
4. *March 19 to April 03, 2014* - DepED continuously followed up with the DBM for a response.
5. *April 04, 2014* - The office of DBM Undersecretary Laura Pascua formally responded through a letter. In the response, the DBM approved the partial list of employees who will avail of the said retirement/separation option under EO 366. The approval was given with the condition that "the number of affected employees who opted for retirement/separation would not exceed the number of funded positions being offered for

abolition by the DepED" as provided under item i, Section 13 of the Implementing Rules and Regulations of EO 366, s.2004.

With the DBM approval of the partial list of retirees, all offices concerned in the processing and monitoring of retirement/separation benefits shall resume all activities related to the matter.

Heads of offices are also directed to inform all concerned employees regarding this update.

Please be guided accordingly.
