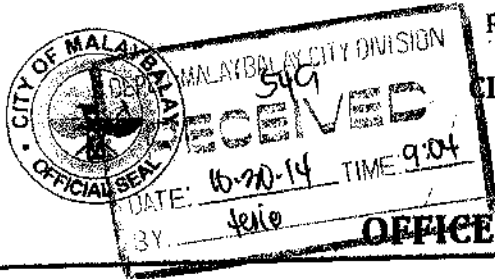

Series of 2014

AMENDING EXECUTIVE ORDER NO. 25 SERIES OF 2012 AND INCREASING THE SCOPE OF AUTHORITY OF MR. HERCULANO S. RONOLO, CITY ADMINISTRATOR, TO SIGN CHECKS INVOLVING REGULARLY RECURRING ADMINISTRATIVE EXPENSES

WHEREAS, Executive Order No. 25, Series of 2012, was passed delegating Mr. Herculano S. Ronolo, then City Administrator-Designate, the authority to countersign checks drawn by the City Treasurer whenever designated as Officer-in-Charge of the Office of the City Mayor;

WHEREAS, Sec. 345, Title V of the Local Government Code of 1991 provides that checks in settlement of obligations shall be drawn by the local treasurer and countersigned by the local administrator;

WHEREAS, it is imperative to vest Mr. Ronolo with authority to sign checks involving regularly recurring administrative expenses to expedite the processing of disbursements;

NOW THEREFORE, I, IGNACIO W. ZUBIRI, Mayor of the City of Malaybalay, by virtue of the power vested in me by law, do hereby authorize Mr. Herculano S. Ronolo in his capacity as City Administrator, to sign checks for utility bills, salary, allowances and wages, remittances of CGMEA and MACEMPC as well as those remittances to government creditor agencies such as, but not limited to, the BIR, GSIS, PAG-IBIG and PHILHEALTH, regardless of the amount involve.

All orders and issuances, or parts thereof, which are inconsistent with this Executive Order are hereby repealed or modified accordingly.

This Order shall take effect immediately.
