4. The schools are expected to submit a report of all the activities conducted during the campaign period on or before December 18, 2014 *Attr:* Rosie A. Salupado.

**2014 ANNUAL 18-DAY CAMPAIGN TO END VIOLENCE
AGAINST WOMEN AND CHILDREN (VAWC)**

1. Pursuant to Republic Act (RA) No. 10398 dated March 19, 2013, entitled *Declaring November 25 of Every Year as National Consciousness Day for the Elimination of Violence Against Women and Children (VAWC)*, the **2014 Annual 18-Day Campaign to End Violence Against Women and Children (VAWC)** will be conducted with the theme *End VAW Now! It's our Duty* from November 25 to December 12, 2014.

2. The Campaign aims to:

- a. increase awareness of rights-bearers on violence against women and children and to augment the efforts of duty-bearers in eliminating gender-based violence;
- b. increase commitment of rights-holders in eliminating violence against women and children; and
- c. forge partnerships among stakeholders in addressing VAWC.

3. All DepEd offices, including the regional and schools division offices and schools, are encouraged to undertake the following or similar activities during the campaign period:

- a. Walk-off activity, Walk to End VAW, organized by the Philippine Commission on Women (PCW) on *November 25, 2014* at the Quezon Memorial Circle, Quezon City;
- b. Online thread about the observance and uploading of activity photos in the PCW Facebook account;
- c. Conduct of *area* to disseminate information on various forms of VAW in their respective offices and schools and their stakeholders;
- d. Conduct of Poster-Making Contest sponsored by PCW for secondary schools;
- e. Conduct of school level contests (essay writing, poster-making, slogan-making, among others) and activities;
- f. Hanging of streamers announcing the campaign; and
- g. Production and distribution of education and information materials in the central, regional and division offices and schools.

4. All expenses relative to the campaign shall be charged to the GAD Funds, subject to the usual accounting and auditing rules and regulations.

5. All regional offices are expected to submit a **consolidated report** of all the activities conducted during the campaign period on or before **December 22, 2014** to the GAD Focal Point System Secretariat, Attention: **Ms. Maria Lourdes D. Pantoja**, Director III, National Educators Academy of the Philippines (NEAP) and concurrent Officer-in-Charge (OIC) Staff Development Division-Human Resource Development Service (SDD-HRDS), Rm. 205, Teodora Alonzo Bldg., Department of Education Central Office (DepEd CO), DepEd Complex, Meralco Avenue, Pasig City.
