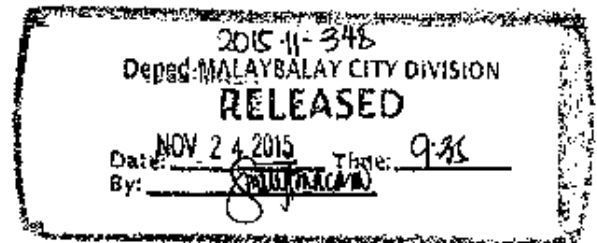

The objective of the training is to update and train teachers on different strategies in teaching Physical Education for a specific disability.

The participants to the Adapted PE training are PE teachers handling students with special needs and participants to the SPED National Conference are SPED coordinators of schools with support funds in 2015.
