

EXECUTIVE ORDER NO. 19
Series of 2015

**AN EXECUTIVE ORDER SUSPENDING THE CLASSES OF SAN JOSE
ELEMENTARY SCHOOL, MALAYBALAY CITY**

WHEREAS, Executive Order No. 66, series of 2012 authorizes local chief executives of local government of units to suspend classes on both public and private schools in the event of severe weather disturbances;

WHEREAS, DepEd Order No. 43, series of 2012 authorizes local chief executive to declare localized cancellation/ suspension of classes in public schools in the event of severe weather disturbances;

WHEREAS, on August 4, 2015, heavy and continuous rain have caused flooding in Sitio Panamucan, Brgy. San Jose, this City, necessitating the pre-emptive evacuation of residents of the said area to the San Jose Elementary School, the designated evacuation center of Barangay San Jose;

WHEREAS, the covered court and various classrooms of San Jose Elementary School are being temporarily utilized as shelters for the evacuated residents, thereby causing disruption in the classes of the said school;

WHEREAS, the presence of evacuated residents causes unfavorable condition and undue stress to the pupils and teaching staff of the said school which makes the conduct of classes not suitable for effective learning environment;

WHEREAS, due to this condition, there is a need to officially suspend the classes of the San Jose Elementary School, this City to facilitate the proper shelter of the evacuated residents and to spare the pupils and the teachers from the inconvenience of unfavorable classroom conditions;

NOW THEREFORE, I, IGNACIO W. ZUBIRI, City Mayor of Malaybalay City, by the powers vested in me by law, do hereby SUSPEND the classes in San Jose Elementary School, this City, effective August 5, 2015.

This Order shall remain effective until revoked.
