



AN ORDER IMPLEMENTING TRAFFIC RE- ROUTING SCHEME FOR THE UPCOMING MALAYBALAY CITY CHARTER DAY 2016 ACTIVITIES AT PORTION FORTICH STREET (NEAR GAISANO) ON MARCH 19, 2016

WHEREAS, the Traffic Management Center (TMC) of the City of Malaybalay has recommended the following re-routing schemes to avoid disorderly traffic congestion during the conduct of Malaybalay City Charter Day 2016 activities at portion Fortich Street (near Gaisano) on March 19, 2016;

WHEREAS, in view of the foregoing and in consonance with the mandate of Section 16 of the Local Government Code of 1991, to enhance public health, safety, convenience, maintain peace and order, among others, thus the need to promulgate this order;

NOW THEREFORE, I, IGNACIO W. ZUBIRI, Mayor of the City of Malaybalay, by virtue of the power vested in me by law, do hereby order the implementation of the following traffic re-routing scheme, to wit;

Section 1. TRAFFIC RE-ROUTING SCHEME. All southbound vehicles from Sayre Highway shall pass at Don Carlos Street (entry point) to Guingona Street and exiting to Capt. Juan St.-Sayre Highway.

All northbound vehicles from Sayre Highway shall pass at Rizal Street (entry point) to Magsaysay Street exiting west to Claro M. Recto St.-Sayre Highway;

Section 2. IMPLEMENTATION. The Traffic Management Center (TMC) are hereby enjoined to strictly implement this order and provide prior traffic advisories to ensure smooth and orderly flow of traffic during the conduct of Malaybalay City Charter Day 2016 activities at portion Fortich Street (near Gaisano) on March 19, 2016.

This order shall take effect on March 19, 2016.
