Subject: SELECTION for Bb. PALARONG PAMPOOK 2016

1. In preparation for the participation to the 2016 Palarong Pamook on Dec. 12-16, 2016 at Camiguin, this Office shall conduct a "Selection for Bb. Palarong Pamook 2016" on December 2, 2016, 8:30AM at the Malaybalay City Central School Gym.
2. The selection/search is open to all public secondary school female students. There shall be one (1) entry/candidate per school officially endorsed by the school head. Private secondary schools with qualified athletes are also encouraged to participate who meet the following minimum requirements, to wit:
 - 2.1 Candidate must be at least a Grade 7 to Grade 11, aged 12 to 18 years old, and preferably with a Height of 5'4" and above.
 - 2.2 There will be three (3) exposures only: School Uniform, Sports Attire (choice of the candidate from the 17 sports events) and White Shorts with any White Upper paired w/ heeled shoes.
 - 2.3 The Criteria for Judging:

1. Beauty of the Face	- 30%
2. Intelligence (Communication Skills)	- 25%
3. Festival Attire	- 10%
4. School Uniform	- 10%
5. Sports Attire	- 15%
6. Poise & Personality	- 10%
TOTAL	= 100%
