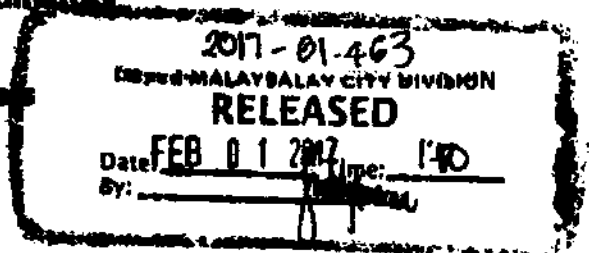

- College graduate, preferably of Education course
- Let passer, an advantage
- Not currently employed as a regular public school teacher
- A resident of the target community/division
- Ability to speak the language of the community (mother tongue/regional language)
- Willing to undergo training on ALS
- In good physical condition
- Has good public relations

**3. All applicants shall submit a written application supported by the following documents:**

- a. Certified photocopy of PRC Professional Identification Card
- b. Certified photocopy of the ratings obtained in the Licensure Examination of Teachers (LET)/ Professional Board Examination for Teachers (PBET), *(if education graduate)*
- c. Certified copy of the Voter's ID or any proof of residency as deemed acceptable by the Division Selection Committee
- d. Certification from the tribal chieftain (if applicable)
- e. Medical Certificate (fit to work/travel to remote areas)
- f. Service Record/Certification signed by the appropriate authority for relevant teaching experience
- g. Certificates of trainings attended if any

4. All applications shall be received and screened at the Division Office.

5. Deadline for submission of applications is on **February 07, 2017 (Tuesday)**. The date of the screening and interview will be **February 9** (for Districts I-V) and **February 10** (from Districts VI to X) at **8:00 AM - 5:00 PM** in DepEd Division of Malaybalay City Multipurpose Hall, Casisang Malaybalay City.
