

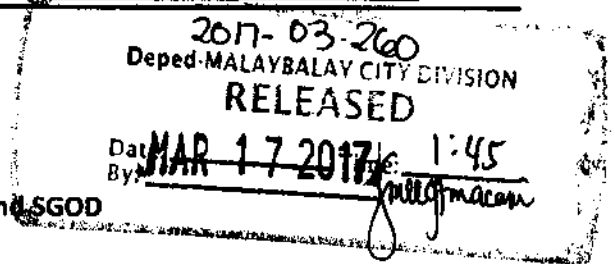

**RE:** Dissemination of Region Memorandum No. 119, S. 2017 – Corrigendum and Addendum to Region Memorandum No 59, S. 2017 (Policy on the Conduct of End of School Year Rites)

1. Pursuant to the herein Region Memorandum No. 119, S. 2017, this Office hereby disseminates the Corrigendum and Addendum to Region Memorandum No. 59, S. 2017 which provides the policy on the conduct of end of the School Year Rites.

2. This Office reiterates important provisions, as stated below:

1. *With the issuance of DepED Order No. 8, s. 2017 entitled "School Year 2016-2017 End of School Year Rights" and the strong clamour of some parents of graduating students, the following modification is hereby adopted to Paragraph 2.b of the issued Region Memorandum No. 45, s. 2017, to wit:*

*"b. Wearing of school uniform during the graduation ceremony is encouraged to avoid unnecessary expenses. The wearing of the toga can be allowed only upon the instance of the majority of the graduating parents in a consultation called for this purpose. However, the none wearing of the same shall not preclude a student from joining the graduation rites or moving-up ceremony."*

2. *As likewise expressly provided in the cited Order, the ceremonies shall focus on the theme **Sabay-Sabay Na Hakbang Tungo sa Maunlad na Kinabukasan** to highlight on the importance of the concerted endeavor and collaborative efforts of the stakeholders and learners in forging a better progressive future for the Filipino youth.*
