AMENDMENT TO DEPED MEMORANDUM NO. 166, S. 2016

(Appointments and Assignments of Undersecretaries and Assistant Secretaries)

To: **Undersecretaries** Assistant Secretaries Regional Secretary, ARMM Bureau and Service Directors Regional Directors Schools Division Superintendents Division Chiefs and Unit Heads

- 1. The Department of Education (DepEd) hereby institutes the following amendments to the assignments of Undersecretaries (USec.) and Assistant Secretaries (ASec.):
 - a. ASec. Revsee A. Escobedo shall be in charge, jointly with USec. Jesus Lorenzo R. Mateo, of Field Operations;
 - b. Further, USec. Mateo and ASec. Escobedo shall likewise jointly supervise the Bureau of Human Resource and Organizational Development (except for Personnel Division and Employee Welfare Division);
 - c. USec. Victoria M. Catibog shall be in charge of the Personnel Division and Employee Welfare Division; and,
 - d. USec. Alain Del B. Pascua shall be in charge of the Cash Division.
- These amendments are instituted pursuant to the authority of supervision and control of the Department vested in the Secretary by the Administrative Code of 1987 and by Republic Act No. 9155 entitled Governance of Basic Education Act of 2001.
- The appeal of the Bureau of Human Resource Organizational Development (BHROD) Director to keep the Personnel Division and Employee Welfare Division integrated under the BHROD is presently being studied.
- This Memorandum modifies DepEd Memorandum No. 166, s. 2016 and DepEd Memorandum No. 118, s. 2016 in all relevant parts.
- 5. Immediate dissemination of this Memorandum is desired.
