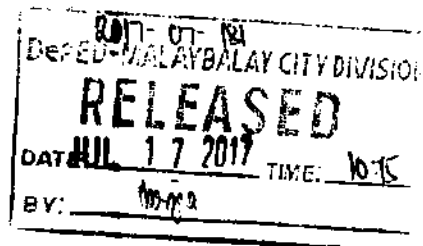

SUBJECT: DIVISION ENHANCEMENT TRAINING WORKSHOP IN REMEDIAL READING CLASS ACTIVITIES IN THE K TO 12 CURRICULUM: AN INTERVENTION FOR PROJECT READ



1. Relative to the implementation of Malaybalay City Division's **Project READ (Ready to Engage on Activities for Developing Reading)**, this Office will conduct a Division Enhancement Training Workshop in remedial Reading Class Activities in the K to 12 Curriculum: An Intervention for Project READ Implementation on August 3 and 4, 2017 at Veranda, Casisang, Malaybalay City.

2. This enhancement training aims to:

2.1 Enhance Remedial Reading Activities among elementary and secondary English classes;

2.2 Provide activities that would nurture the English Teachers skills in formulating appropriate Instructional Materials, both manipulative (mIM) and Computer Aided or Electronic IM (eIM) and Work Activities for Remedial Reading in English appropriate for the K to 12 Curriculum;

2.3 Show the importance of reading among learners by expressing it through varied shared approaches; and

2.4 Make IMs both **manipulative (mIM)** and **electronic (eIM)** copies for Remedial Reading Program Implementation.

3. Participants to this enhancement training workshop are Elementary and Secondary English Teacher in any Grade Level and preferably a computer literate, one from every elementary and secondary school recommended by the School Head. Participants are required to bring laptop with extension wire, pocket wifi and the school's result of the 2016-2017 PHIL-IRI Post Test.

4. Meals and snacks are chargeable against Human Resource Training Development - Division Office (HRTD-DO) Funds while travel expenses of all participants will be charged against local funds subject to usual accounting and auditing policies, rules and regulations.
