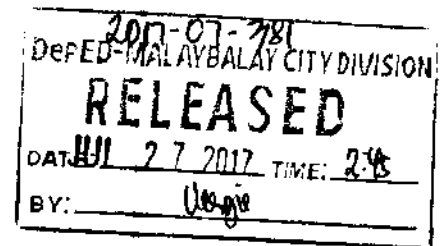

TORRIZO, MD, MPH Director IV ROX DOH** dated July 24, 2017 re: **Post Deworming Assessment and Quality Data Check Meeting** at Green Ridge Apartelle, Malaybalay City on July 28, 2017 for Districts I-VI and July 31, 2017 for Districts VII-X respectively.
2. The activity is part of the Post Harmonized Schedule and Combined Drug Administration Assessment of the ongoing Mass Drug Administration and 1<sup>st</sup> round deworming of children 1-18 years old.
3. Elementary/secondary School Heads (SHs) are advised to inform the school clinic teachers/in-charge to report to the venue as scheduled. Moreover, participants are requested to bring the school consolidated deworming reports indicating observed cases of mild/moderate adverse reactions. Deworming forms may be **downloaded under School Health Section in the Division website**.
4. Free Lunch and two snacks of participants will be shouldered by the sponsoring agency. Travel expense shall be charged against local/school funds subject to existing accounting and auditing rules and regulations.
