

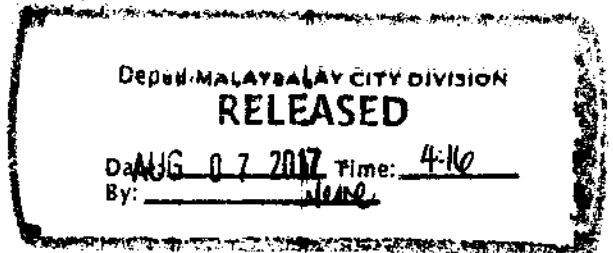

Re: **CONSULTATIVE CONFERENCE-WORKSHOP ON INDIGENOUS PEOPLES EDUCATION (IPEd) PROGRAM IMPLEMENTATION [PHASE 1]**

1. Pursuant to **DepEd Order No. 62 s. 2011** entitled *Adopting the National Indigenous Peoples Education Framework*; **DepEd Order No. 32, s. 2015** entitled *Adopting the Indigenous Peoples Education [IPEd] Curriculum Framework* ; and **DM-CI-2017-00191** re: *Quality Assurance of Contextualized Lesson Plans for Indigenous Peoples Education [IPEd] and Management of Learning Action Cells [LAC] in IPEd-implementing Schools*, the Division of Malaybalay City will conduct a **Consultative Conference on Indigenous Peoples Education [IPEd] Implementation [Phase 1]** on August 15, 2017 at the Garden Party Venue, Claro M.
