

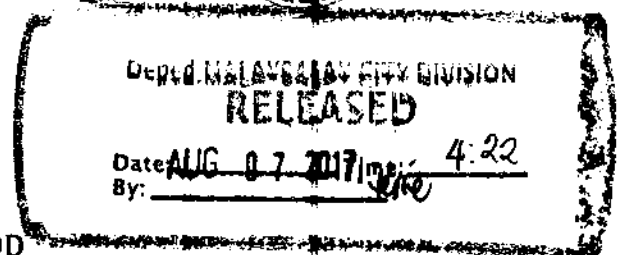

Re: **TRAINING-WORKSHOP ON THE FINALIZATION AND REVIEW OF CONTEXTUALIZED LESSON PLANS FOR INDIGENOUS PEOPLES EDUCATION (IPEd), KINDERGARTEN AND GRADE 1**

1. Pursuant to **DepEd Order No. 62 s. 2011** entitled *Adopting the National Indigenous Peoples Education Framework*; **DepEd Order No. 32, s. 2015** entitled *Adopting the Indigenous Peoples Education [IPEd] Curriculum Framework* ; and **DM-CI-2017-00191** re: *Quality Assurance of Contextualized Lesson Plans for Indigenous Peoples Education [IPEd] and Management of Learning Action Cells [LAC] in IPEd-implementing Schools*, the Division of Malaybalay City will conduct a **Training-Workshop on the Finalization and Review of Contextualized Lesson Plans for Indigenous Peoples Education [IPEd]** on August 8-10, 2017 at the Garden Party Venue, Claro M.
