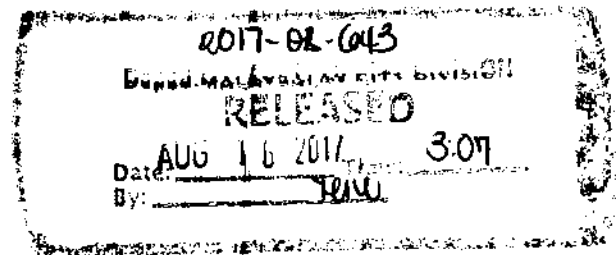

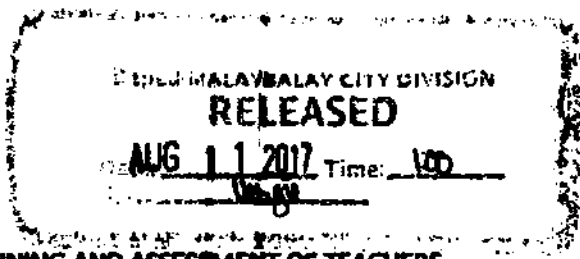

SUBJECT: FIRST SPECIALIZED SKILLS ENHANCEMENT TRAINING AND ASSESSMENT OF TEACHERS

DATE: August 1, 2017

1. Pursuant to Republic Act No. 10533 also known as the *Enhanced Basic Education Act of 2013* and moving towards the realization of K to 12 Curriculum goals which aims to produce learners that are ready to be part of the workforce. This Office announces the conduct of the *1st Specialized Skills Enhancement Training and Assessment of Teachers* in different qualifications. Orientation of participants will be done on August 22, 2017 at the venue to be announced later.

2. This specialized skills training offers the following qualifications:

3. Participants are limited to a maximum of ten (10) per qualification (first come first serve) and required to submit Letter of Intent and Recommendation from their school head to the School Division Superintendent, Attention: Mr. Luis S. Alajar Jr. EPS in TLE before August 15, 2017. Hence, participants should bring the following during the training:

- 3.1 Ingredients/tools/minor equipment needed in each qualifications
- 3.2 Personal Protective Equipment (PPE)
- 3.3 Eight (8) pieces Passport size picture (TESDA standard)

4. School Heads shall give priority to teachers teaching EPP/TLE subjects without National Certificate and shall make necessary arrangements as to who will handle the affected schedule of teachers qualified to attend this training and assessment.
