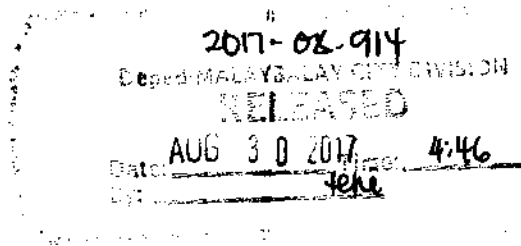

1. Pursuant to **DepEd Order No. 62 s. 2011** entitled *Adopting the National Indigenous Peoples Education Framework*; **DepEd Order No. 32, s. 2015** entitled *Adopting the Indigenous Peoples Education [IPEd] Curriculum Framework* and **DM-CI-2017-00191** re: *Quality Assurance of Contextualized Lesson Plans for Indigenous Peoples Education [IPEd] and Management of Learning Action Cells [LAC] in IPed-implementing Schools*, the Division of Malaybalay City will conduct a **Division Retooling of Teachers and School Heads in Additional Schools Serving IP Communities Cum Production of Learning Materials for the Indigenous Peoples Education [IPEd] Program** on September 20-22, 2017 at the Garden Party Venue, Claro M.
