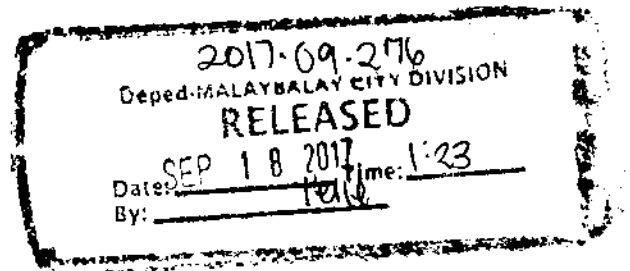

**IMPLEMENTATION OF THE CONTINUING PROFESSIONAL DEVELOPMENT
REQUIREMENT FOR THE RENEWAL OF THE
PROFESSIONAL IDENTIFICATION CARDS OF NURSES**

WHEREAS, Republic Act (R. A.) No. 10912, otherwise known as the Continuing Professional Development Act of 2016, lapsed into law on July 21, 2016;

WHEREAS, Section 10 of R. A. No. 10912 provides that the Continuing Professional Development (CPD) shall be a mandatory requirement in the renewal of the Professional Identification Cards (PICs) of all registered and licensed professionals under the regulation of the Professional Regulation Commission (PRC);

WHEREAS, Section 10 of PRC Resolution No. 1032, s. of 2017 or the implementing Rules and Regulations (IRR) of Republic Act No. 10912, otherwise known as the "Continuing Professional Development Act of 2016", provides that all registered and licensed professionals shall complete the required credit units (CUs) every three (3) years of compliance period;

WHEREAS, the Professional Regulatory Boards (PRBs) are given the power to prescribe the required number of CPD CUs as well as the period within which to comply therewith;

WHEREFORE, pursuant thereto, the Professional Regulatory Board of Nursing (Board) hereby **RESOLVES**, as it so **RESOLVED**, to set the minimum CUs required for the Nursing profession as follows:

Year of Renewal	Required Number of CPD CUs	Minimum allowed to be earned per year
January-December 2017	0	0
January-December 2018	15	15
January 2019 onwards	45	45

This Resolution shall take effect upon approval.


