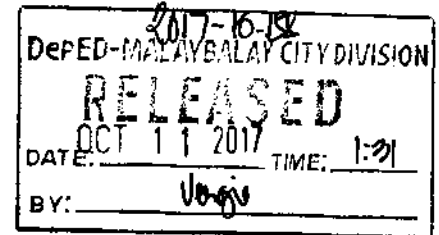

This Office is in receipt of complaints regarding "collections from and contributions of teachers to cover expenses of activities in celebration of National Teachers' Day and World Teachers' Day. The report on compulsory amounts ranging from P100 to as high as P1,800 are for various activities such as bingo games, Zumba, and raffle, usually exacted from them without their consultation and/or approval."

This Office strongly emphasizes the strict compliance to all DepEd issuances pertaining to collection of fees or contributions on voluntary basis consistent with DepEd Order No. 41 s.2012. Any violation of this Order by any teacher, school official or school personnel shall be dealt with administratively, pursuant to DepEd Order No. 49, s. 2006 entitled "Revised Rules of Procedure of the Department of Education in Administrative Cases."
