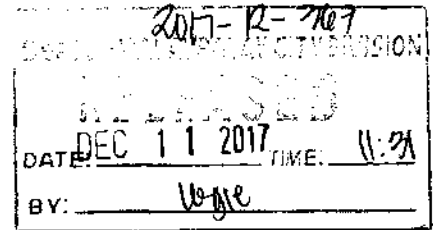

**2017 OBSERVANCE OF THE 18-DAY CAMPAIGN TO END VIOLENCE
AGAINST WOMEN AND CHILDREN**

1. The Philippine Commission on Women (PCW), in coordination with the Inter-Agency Council on Violence Against Women and their Children (IACVAWC), spearheads the nationwide 2017 Observance of the 18-Day Campaign to End Violence Against Women and Children with the theme VAW-Free Community Starts with Me from November 25 to December 12, 2017.

2. This is pursuant to Presidential Proclamation No. 1172, s. 2006 entitled 18-Day Campaign to End Violence Against Women (VAW), and Republic Act 10398, s. 2012 entitled An Act Declaring November Twenty-Five of Every Year as National Consciousness Day for the Elimination of Violence Against Women and Children.

3. To promote public awareness about the campaign, all offices of the Department of Education, including regional and schools divisions offices and schools, are encouraged to undertake the following suggested activities:

- a. Hanging of streamer bearing this year's campaign theme. Streamer design can be downloaded from the PCW website:
<http://pcw.gov.ph/VAWfreePH2017>;
- b. Uploading of the official logo and advocacy materials for the campaign in school's official website or social media site;
- c. Development of information, education, and communication (IEC) materials like fans and flyers for distribution to clientele. PCW-developed materials may be reproduced by any organization, provided that the content and design of the material is retained. Printer-ready copy of the materials can be downloaded from <https://tinyurl.com/anti-VAW-IEC>. The uploaded materials are designed for interested organizations to incorporate their official logo below the phrase **Reprinted and distributed by** so that due acknowledgment could be given to their contribution to the campaign;
- d. Organizing activities related to this year's theme and focus during the campaign period, and conducting school/district/division level contests (essay writing, poster making, slogan making, among others);

- e. Participation in online campaign threads and discussions about the observance using #VAWfreePH;
- f. Participation in the nationwide Orange Your Icon Advocacy Initiative; and
- g. For regional/field offices: Coordination with other government regional offices or local government units (LGUs) for inter-agency/LGU collaboration in holding a kickoff activity on **November 24, 2017**. Refer to the enclosed suggested program: VAW: The Unspoken Words. Requirements and materials relative to the program can be downloaded from <http://pcw.gov.ph/VAWfreePH2017>.

4. Expenses related to the 2017 Observance of the 18-Day Campaign to End VAW shall be charged to the Gender and Development (GAD) budget of government offices, subject to the usual accounting and auditing rules and regulations.
