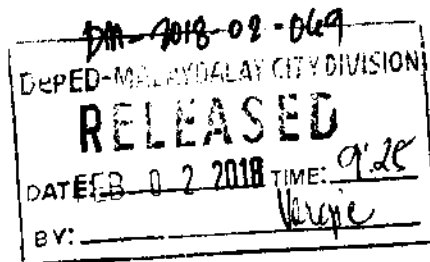

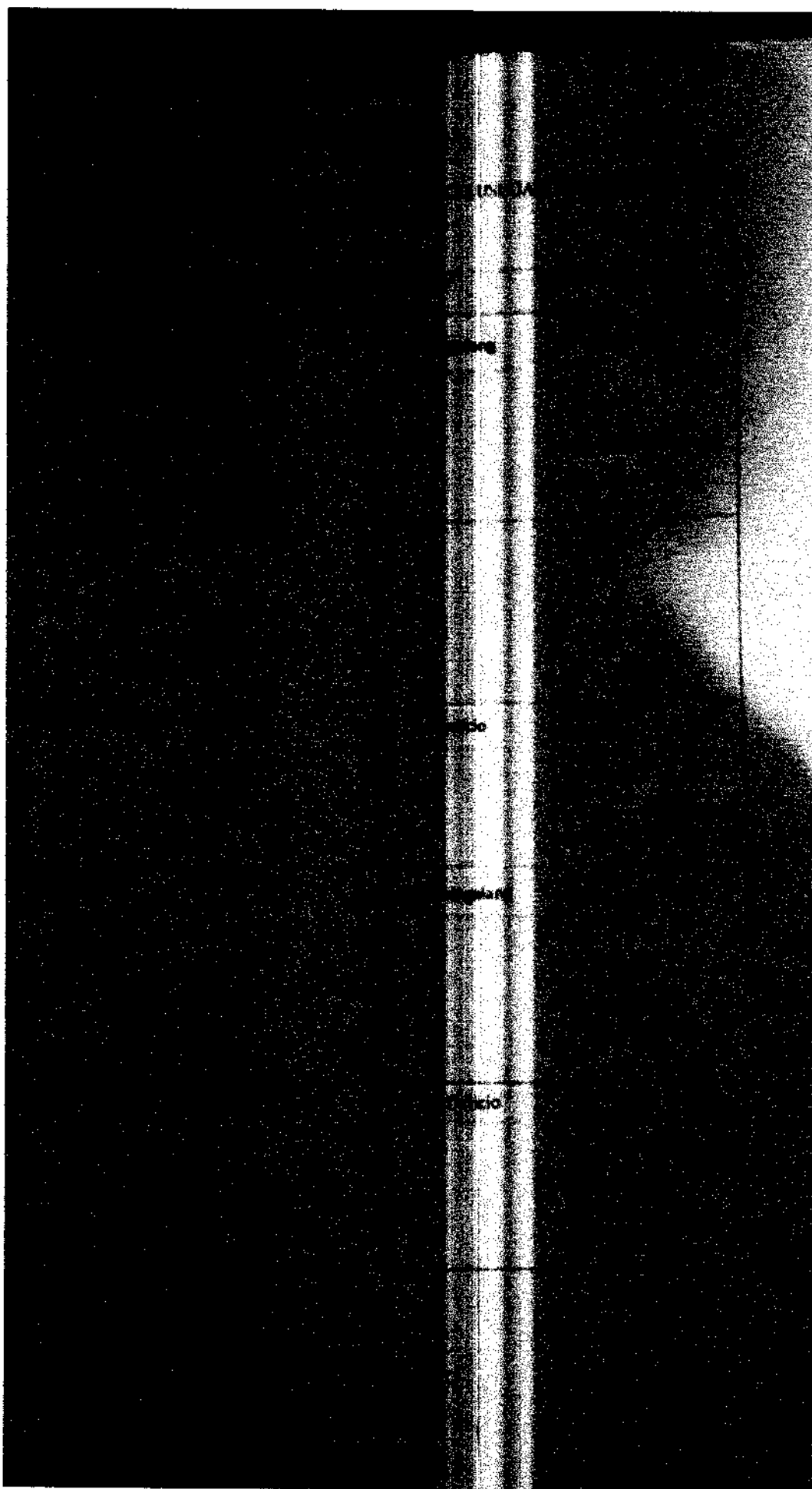
- Parallel to DM no. 22.s.2015 re: **Annual Physical Examination of DepEd Employees (Teaching and Non-Teaching Personnel)** and in compliance with Civil Service Commission (CSC) Memorandum Circular No. 17, s.1989, **All Division Teaching and Non-teaching employees** are advised to undergo physical examination for SY 2017-2018 as part of the personnel clearance from accountabilities.
- Further, all personnel are encouraged to avail of the OUT-PATIENT services of **Tamang Serbisyo Para sa Kalusugan ng Pamilya (TSEKAP)** formerly known as Primary Health Care Benefit (PCB 1) Package. The City Health Offices Physicians shall perform health examination of newly hired personnel using the annual Health Examination Form 86 for TSEKAP enlistment. Other permanent employees who were already enlisted with TSEKAP package may seek medical clearance from any government physician other than the City Health Office.
