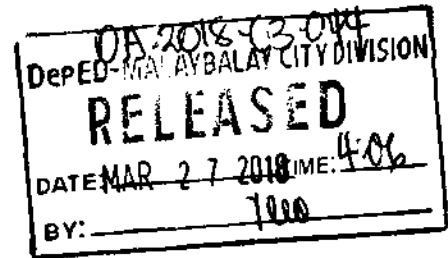

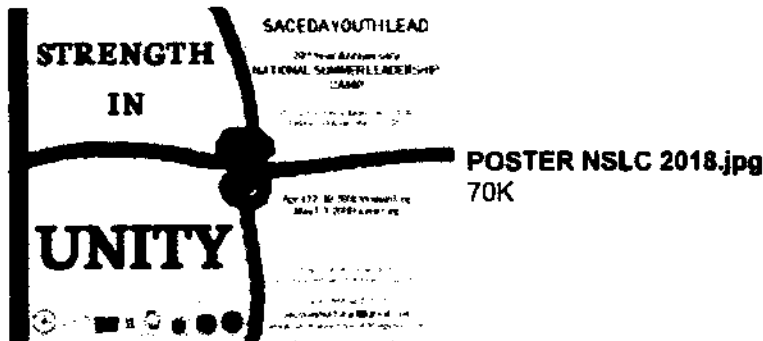

1. define leadership and leadership development;
