1. Pursuant to the provisions of Section 1, Rule IX of Republic Act 7079, also known as *Campus Journalism Act of 1991*, this Office, through the Curriculum and Learning Management Division (CLMD), announces the 2018 Regional Schools Press Conference (RSPC) on the theme *Fostering 21<sup>st</sup> Century Skills and Character-based Education through Campus Journalism*, to be hosted by the Division of Tangub City, Tangub City, Misamis Occidental, on December 11-14.

2. The conference aims to achieve the following objectives:

- Outline the importance of journalism by expressing it through different journalistic endeavors and approaches;
- Sustain advocacy on social consciousness;
- Provide a venue for an enriching learning experience for learners interested in pursuing journalism as a career
- Promote responsible journalism and fair ethical use of social media; and
- Enhance journalistic competence through healthy and friendly competition.

3. The conference activities shall include the following in two levels: elementary and secondary (including Senior High School), and of two media: English and Filipino: Group Contests; Individual Contests ~~(with the inclusion of ...)~~; Radio Scriptwriting and Broadcasting Contests; TV Scriptwriting and Broadcasting (secondary level only); Collaborative Desktop Publishing Contest; Collaborative Online Publishing (Contestants of Collaborative; Desktop Publishing (secondary level only); and Awarding of winners in the paper category and the Search for Outstanding School Paper Advisers (SPAs) and Campus Journalists (CJs).

4. Participants are the top- three winners of the Division Schools Press Conference, except for the Scriptwriting and Radio Broadcasting and Collaborative Publishing Contest where only the top group per level and

category is allowed to join, team of TV Broadcasting in the secondary level composed of seven (7) members, coaches/advisers, divisional and regional EPS in English and Filipino, chiefs of the CID and CLMD, board of judges ,and the technical working group of the regional and divisional offices.

5. DepEd is a staunch advocate of smart, creative and original expression of thoughts and ideas. It respects Intellectual Property Rights and adheres to the rule of law concerning plagiarism. Any printed or online publication found to have copied and published texts, graphics and other materials without duly acknowledging their sources will be disqualified from the competition. Any individual who fails to adhere to these guidelines shall be dealt with accordingly. In addition, **any unnecessary markings found in the contest paper during the individual or group competition shall disqualify the contestant/s.**

6. The references for the contest mechanics and criteria are the implementing guidelines stipulated in DepEd MEMORANDUM No. 200, s. 2017. If there will be additional guidelines, all Schools Division Offices will be informed accordingly.

7. All SDOs shall strictly follow the **No School Paper, No student contestant** policy. Upon registration, each participating school has to submit one (1) print copy of the school paper.

10. Each participant shall be charged with a registration fee of **Three Hundred Pesos (P 300.00)** to cover honoraria of judges, trophies, and medals, kits, supplies, and other operational expenses. **This amount shall be collected by the host division.** Meals of participants shall be shouldered by the participating delegation.

11. Winners in this RSPC and who will likely be included in the delegation for NSPC shall stay after dinner of the last day for important reminders.

12. Registration fee, travel, and other related expenses for this activity shall be charged against local funds, journalism funds, PTA funds or any other
