1. Per Regional Memorandum No. 03, s. 2013, dated January 7, 2013, informed all Private Schools Administrators and operators re: **2nd Congress of Private Schools Administrators and Operators**, to be held on January 30, 2013 at Atrium, Lim Ket Kai, Cagayan de Oro City, in consonance with DepEd Memorandum No. 88, s. 2010 known as the **Revised Manual of Regulations for Private Schools in Basic Education** and pursuant to the implementation of Universal program on "Education For All.
