These processes and procedures shall include the recording and tracking of individual loan accounts, preparation of reports, among others. The Project Team also ensure the development of the 1 of 2 manual of operations to support the Provident Fund System.

- 3. To support the Project Team, five IT consultants will be engaged for the duration of the development of the system, to be composed of:
 - Team Leader
 - Two Systems Analysts/Designers (Industry Grade)
 - One Application Developer (Industry Grade)
 - One Database Administrator (Industry Grade)
- 4. All expenses incidental to the development of the Provident Fund System, including among others but not limited to salaries of the IT consultants, shall be charged to the interest earnings of the high yield account of the DepEd Provident Fund.
