**DIVISION MEMORANDUM** s. 2013

#### GUIDELINES FOR TEACHER TRANSFEREE APPLICANT

TO: Education Program Supervisors-Designate and Division Coordinators-Designate Public Schools District Supervisors Elementary and Secondary School Principals Section Heads All Others Concerned

- 1. For the information and guidance of all concerned applicants for transfer within the Division and from other Division, the following guidelines shall be followed by this Office as agreed during the last Management Committee (MANCOM) Meeting on February 15, 2013 of this Division:
  - 1.1. The policy of ranking within the Division is based on Section 8 of GAA 2012 as stipulated in DepEd Order No. 37, s. 2012 which provides the Addendum to DepEd Order No's. 12 and 25, s. 2012; Section 9 of GAA 2013; and, DepEd Order No. 3, s. 2013 which provides the Amended Implementing Rules and Regulations (IRR) of Republic Act No. 8190.
  - 1.2. There shall be a separate ranking for transferees from within the Division and those outside of the Division.
  - 1.3. Transferees within the Division shall be the priority for transfer in keeping with the provision of GAA 2013, Section 9 while those from outside of the Division shall be accommodated as long as the above provision is already complied.
  - 1.4. Applicants for transfer shall submit the following documents:
    - a. Certification from the School Head indicating the length of service in the present station duly attested by the Schools District Supervisor (see Enclosure 3;
    - Performance Rating for the last three (3) rating period;
      - b.1. CBPAST SY 2012-2013
      - b.2. CBPAST SY 2011-2012
      - b.3. PAST SY 2010-2011
    - c. Certified photocopy of Voter's Registration Record; and,
    - d. Omnibus Certification of authenticity and veracity of all documents submitted.
  - 1.5. Transferees shall apply in the school where his/her residence is located. In the event that no school is situated in the barangay, the school nearest to his/her residence shall be the school to apply, or to any school of his/her choice. Chairman testifying that there is no school in the barangay where the applicant for transfer resides.

- 1.6. All documents of the applicants for elementary shall be addressed to the Schools Division Superintendents through the Schools District Supervisor of the district where the school is located. For secondary, it will be likewise addressed to the Schools Division Superintendent through the School Principal where she/he is applying for. Deadline for submission of documents is on or before June 7, 2013.
- 1.7. The District Ranking Committee shall convene with the District Steward to evaluate the documents submitted and the rate the applicants for transfer using the percentile rate of the following:

Experience - 50% Performance Rating - 50%

1.7.a. Teaching experience of applicants for transfer shall be given one (1) point for every school year but not to exceed 10 points.

For every month of service, 0.1 point shall be given.

Example: 8 months = 0.8 points

11 months = 1.1 points

Formula for computation:

No. of months  $\times 0.5 = ($  )  $\times 100\% =$  weighted points in experience scoring applicant's experience (see Enclosure 1)

- 1.7.b. Equivalent points for Performance Rating of applicants is transmuted with the CBPAST and PAST rating equivalents. (see Enclosure 2)
- 1.8.b. The Chairman of the District Ranking Committee shall submit the List of Teacher Transferees (see Enclosure 4) in hard and soft copies to the concerned District Steward of each district on June 14, 2013.
- 2. For further verification of the guidelines of application for transfer, where exigency of service of such applicant is deemed important, and school profile status, DepEd Order No's. 22 & 23, s. 2013 could be the source for point of clarification and reference for action.
- 3. Immediate and wide dissemination of this Memorandum is highly desired.
