1. As embodied in DepEd Memorandum No. 13, s. 2013, this Office hereby reiterates that the Department of Education (Deped) respects the rights of all Filipino Muslims to observe the *Ramadan* by fasting from July 9, 2013 to August 7, 2013.

- 2. It is further reiterated that having adopted a *flexible time* for all its employees since 1998, this Department shall allow Filipino Muslims who are fasting while working, whether in the Central Office or in local/field offices nationwide, to start rendering their services between 7:00AM and 9:00AM (but not later than 9:00AM) until such time when they complete the eight working hours without noon, a.m. and p.m. breaks that are equivalent to two hours daily during weekdays. This is to ensure continuous, prompt and efficient delivery of public services in basic education.
- 3. Previously, all Filipino Muslims who are working in local or national government offices in areas outside the autonomous regions throughout the country and who are fasting during the month of *Ramadan* rendered their services from 8:00AM to 12:00Noon and from 1:00PM to 5:00PM as their official time. However, the said official time was modified to 7:30AM-3:30PM without noon break and the difference of two hours is not *counted as undertime* by the Civil Service Commission under Paragraph 2 of the Resolution No. 81-1277 dated November 13, 1981, pursuant to Sections 2 and 5 of Presidential Decree No. 292 dated September 12, 1973, as amended by Presidential Decree No. 322 dated October 26, 1973.
