

RESOLUTION No. 9734

WHEREAS, pursuant to the Constitution, the Oranibus Election Code, Republic Act 9164, and other election laws, the Commission on Elections (Commission) may deputize certain departments under the Executive Branch, Government-Owned-and-Controlled Corporations (GOCCs) and Financial Institutions in connection with the October 28, 2013 Synchronized Barangay and Sangguniang Kabutaan Elections

NOW, THEREFORE, the Commission on Elections, has RESOLVED, as it hereby RESOLVES to deputize, the following departments under the executive branch, government-owned and controlled corporations and financial institutions, and to perform specific duties relative to the conduct of the elections, as follows:

1. THE DEPARTMENT OF EDUCATION

The Department of Education (DepEd) shall (a) comply with and enforce all orders and fustructions of the Commission relative to the election duties and functions of its personnel. (b) allow the use of public school buildings for election purposes; (c) not to nold, during the election period, conferences, seminars or any school activity, which might interfere, restrict, or prevent the performance of election duties of its personnel, except upon prior written authority of the Commission, and (d) perform such other duties and functions which the Commission may prescribe from time to time.

H. THE DEPARTMENT OF FINANCE

The Department of Finance (DoF) shalls (a) comply with and enforce all orders and instructions of the Commission relative to the election duties and functions of its personnel, (b) ensure that all provincial, city, and municipal treasurers remain in their present assignments and neither transferred, detailed, reassigned, whether temporarily or permanently, to another province, city or municipality, during the period from September 28, 2013 to November 12, 2013, except upon prior written authority of the Commission, nor allowed to go on leave of absence from office during the period starting two weeks before and two weeks after election day, except upon prior written approval of the Commission. (c) not designate temporary or casual employee as Officer-in-Charge of the Office of the Treasurer; and (d) perform such other duties and functions which the Commission may prescribe from time to time.

II. THE DEPARTMENT OF TRANSPORTATION AND COMMUNICATIONS

The Department of Transportation and Communications (DOTC) and all offices/agencies under the department shall perform the following duties and functions:

- a Circularize to all owners and operators of land and air transportation facilities and telecommunications services, heiders of certificates of public convenience, franchises or other forms of authorization, that the following provisions under the Omnibus Election Code are election offenses:
 - Sec. 89, which prohibits any candidate, political party of organization or any person from giving or accepting transportation, free of charge, directly or inducetly during the five .5) hours before and after a public meeting, on the day preceding the election and on election day.
 - 2 Sec. 95, which prohibits contributions for partisan political activity given directly or indirectly by natural or juridical persons operating a public utility; or by natural or juridical persons who hold contracts or subcontracts to supply the government or any of its agencies, subdivisions or instrumentalities with goods or services or to perform construction or ether work; or by natural or juridical persons who have been granted franchise, incentives, exemptions, or allocations or similar privileges or concessions by the government or any of its agencies, subdivisions of instrumentalities including government-owned or controlled corporations, or by natural or juridical persons who within one year prior to the date of the election have been granted loans or other accommodations in excess of P 100,000 00 by the government or any of its agencies, subdivisions or instrumentalities including government-owned or controlled corporations;

VILTER CIVIL SERVICE COMMISSION

The Civil Service Commission (CSC) shall enforce and implement the provision of the Constitution of the Philippines percontagy paragraph 4, Section 7 (B), Article IX, which provides that

- "(4) No officer or employee in the civil service shall engage, directly or ladisetly, in any electionesting or partiagn political campaign."
- (b) No candidate who has lost in any election shall, within one year after such election, he appointed to any office in the government or any government owned or controlled-corporations or in any of its subsidiaries."

and the provisions of the Omnibus Election Code, particularly Section 261:

"Section 151. Prohibined Acts. — The following shall be guilty of an electron offense.

XXX XXX XXX

g.) Appointment or now employees, treation of new position, promotion, or giving salary increases. During the forty five (45) days before a seguiar election, and thirty (30) days before a special election (1) any hand, official appointing officer of a government office, agency or instrumentality, whether national or total, including government-owned or controlled corporations, who appoints or hires any new employee, whether provisional, temporary or casual, or ottales and fills any new position, except upon authority adupts unities, it is satisfied that the position to be filled is exceptial to the proper functioning of the office or agency concerned, and that the position shall not be filled in a manner that may influence the election.

As an exemption to the foregoing provision, a new employee may be appointed in case of organ need: Provided, however, that notice of the appointment shall be given to the Commission after three days from the date of the appointment. Any appointment or hiding to violation of this troviction shall be not and your

- h.) Transfer of officers and employees in the civil service. Any official who makes or causes transfer or detail of any officer or employee in the civil service including public school teachers, within the election period except upon prior approval of the Commission.
- i.) intervention of outlie officers and employees. Any officer or employee in the civil service, except those holdings political offices; any officer, employee, or member of the Armed Porces of the Philippines, or any police force, special forces, borne defense forces, barangay soff-defense units and all other paramilitary units that now exist or which may hereafter he organized who directly or indirectly, intervenes in any political activity, except to vote to preserve public order, if he is a passer officer."

VIII THE COMMESSION ON AUDIT AND THE DEPARTMENT OF BEINGET AND MANAGEMENT

The Commission on Audit (COA) and the Department of Sudget and Management (DEM) shall enforce and implement the provisions on Sec. 3 of Republic Act No. 3679, which states that "fee construction or maintenance of provincial, city, municipal and barangay funded loads and bridges shall be prohibited for a period of ten (10) days immediately preceding the date of election, the provisions of Section 26), paragraphs (y) and (y), of the Operatus Election Code to the centrary notwithstanding".

IX. DEFARTMENT OF FUBLIC WORKS AND HIGHWAYS AND THE MANE A DVYR OPWRYT ASTROPRITY

The Department of Public works and Highways (OPWH) and the Mount Manile Development Arthority (MIMDA) shall assist the Commission in removing and tearing down all unlawful election materials. The deputation of DPWH shall be nationwide while that of the MMDA shall be limited to Motro Manile only.

The DFWH as well as the MNIDA shall provine facilities and/or equipment necessary in the maring down of Hegal propaganda materials, and perform such other duties and functions as the Commission may prescribe from time to time.

A DEED PHILIPPING INFORMATION ACKNOW

The Pullippine Information Agency (PIA) shall reaform the following duties:

- Assist the Commission in its exocation and information compagn on the aforesaid electrons;
- 2 Make available to the Commission its facilities and services of its personall, as may be recessary to onsure randomination of the programs of activities or operation plans for the Commission's entermanum compagn;
- Freduce such information materials as the Commission may deem necessary to ensure the conduct of free, orderly, honest, peaceful and credible Synchronized Barangey and Sangguinang Kabatana Discrious on October 18, 1013; Provided, that in all cases:
 - a. The Agency shall address shirtly to the policy of the Commission that the education and information campaign must be absolutely impartial, objective and neutral:

- Perform such other duties and functions which the Commission may proscribe from time to time.

XI GOVERNMENT EMANCIAL INSTITUTIONS, OTHER GOVERNMENT AGENCIES, AND OTHER GOVERNMENT OWNER OF COVEROTLES CHEED RATIONS
