Per Unnumbered Regional memorandum dated July 25, 2013 re: Maintenance and Other Operating Expenses (MOOE) Transparency Board, you are hereby directed to create the MOOE Transparency Board.

The Transparency Board shall display the Cash Disbursement Registers from January, 2013 to present. The report must be clear, easy-to read, accessible and up to date. Furthermore, the report must be duly signed by required signatories before posting. Hence, only disbursements which were post-audited and found in order by the Accounting Section shall be allowed for posting.


Teacher Training Facilities

- To be discussed by Asec. Jess Mateo in the near future.




