ADMINISTRATION OF THE 2013 PHILIPPINE EDUCATIONAL PLACEMENT TEST (PEPT)

To: Regional Directors
Schools Division Superintendents
Heads, Public Elementary and Secondary Schools
All Others Concerned

1. The Department of Education (DepEd), through the National Education Testing and Research Center (NETRC), with the assistance of division and school personnel, shall administer the **Philippine Educational Placement Test (PEPT)** on November 17, 2013 (Sunday) for Luzon and **November 24, 2013 (Sunday) for Visayas and Mindanao**. This is pursuant to DepEd Order No. 32, s. 2002 entitled *Administration of Philippine Educational Placement Test (PEPT)* and DepEd Order No. 10, s. 2013 entitled *School Calendar for School Year (SY) 2013-2014*.

2. In cases when there are Grade 6 pupil-registrants who are visually-impaired, the Division Testing/Coordinators (DTCs) will indicate their respective birthdates and last grade/year levels completed and will determine whether they are Braille readers or not in their respective forms. The Braille form of the test booklet for the elementary pupils is different from that for the secondary students.

3. The authorized forwarder/courier of the NETRC shall deliver and retrieve the test materials a week before and after the administration of the test.

4. Immediate dissemination of this Memorandum is desired.
