EXECUTIVE ORDER NO. 31

RECONSTITUTING THE LOCAL COUNCIL FOR THE PROTECTION OF CHILDREN

WHEREAS, Department of Interior and Local Government (DILG) Memorandum Circular 2013-70 was issued to strengthen Civil Society Organizations (CSO) and similar aggrupations to strengthen their participation in local governance and development processes, thus, there is an urgent need to reorganize this Committee;
