- 3. As such, the Division ETF shall render overtime services and perform the following duties:
  - Ensure that teachers shall be provided with adequate information, technical and legal assistance in the course of the performance of their duties as members of the Board of Election Tellers (BETs) as well as principals, supervisors, and other employees of DepEd who will also serve during the Barangay Elections;
  - 2) Serve as DepEd's institutional link to volunteer organizations, individuals as well as partner agencies involved in the elections; and,
  - 3) Perform other related duties from time to time.
- 4. Expenses for the establishment and operation of DepEd-Division ETF shall be charged to the Maintenance and Other Operating Expenses (MOOE) subject to existing accounting and auditing rules and regulations.
