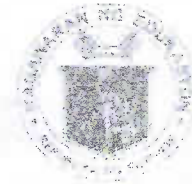



1. For information and guidance of all concerned, this Office hereby disseminates the herein letter dated May 13, 2014 from the Office of the City Election Officer, Commission on Elections pertinent to the on-going registration of voters.
2. As stated in the letter, there are numerous elementary school teachers who have not yet updated their registration records. These require validation (electronic picture, fingerprint and signature), correction of entries (change status), among others. In accordance with Section 3 of Republic Act No. 10367, "An Act for Providing Mandatory Biometrics Voter Registration", a registered voter who has incomplete or/no biometrics shall not be allowed to vote in the coming May 9, 2015 National and Local Elections.
3. Further, this is to reiterate that all DepEd personnel are invited to submit themselves to update their registration records. The City COMELEC is open from Monday to Friday, 8:00AM to 5:00PM only.

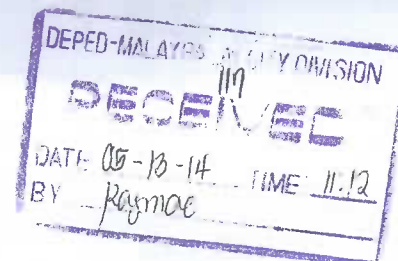
