REITERATING DILG MEMORANDUM CIRCULAR NO. 2010-148, ENTITLED, "REGULATING THE SALE, MANUFACTURE, DISTRIBUTION AND USE OF FIRECRACKERS, POLYVINYL PIPE "BOGA" AND OTHER PYROTECHNIC DEVICES"

To: The Schools Division Superintendents

In furtherance of public safety, order and national security, during the upcoming holiday celebrations, pursuant to Republic Act No. 7183, An Act Regulating the Sale, Manufacture, Distribution and Use of Firecrackers and Other Pyrotechnic Devices, all Division Offices is hereby encouraged to:

- Establish a 'Fire and Pyrotechnic Zone" to serve as a designated area where people may sell firecrackers and pyrotechnic devices;
- Designate an area(s) where people may use said firecrackers and other pyrotechnic devices
- Observe the following common types of firecrackers and pyrotechnic devices that may be manufactured, sold, distributed and used, under the said act:
