- 2 Along this undertaking, school head of this Region are allowed to conduct benchmarking on the school sports program through intensive observation of the games during the 2014 Palarong Pambansa.
- The objectives of this educational engagement are:
 - 3.1 Provide moral support to their athletes coming from their school who are qualified to the 2014 Palarong Pambansa;
 - 3.2 Observe the best sports practices of other teams during the games and adopt these in the school/district level school sports competitions; &
 - 3.3 Learn the national standard facilities of Palarong Pambansa.

- It is advised that they must focus their study on the sports event where their qualified athletes excelled. The information gathered shall be presented in the evaluation during the yearly evaluation conference workshop for sports stakeholders as intervention for future use.
- Because of space limitation, school principals are restricted to join the billeting quarter at Balian National High School and Victor de Guia Memorial Elementary School. However, this Office requested Pangil Central School as billeting quarter of the school heads. Also, it is understood that they should take care of their own meals as they can claim per diem for this travel.
- School heads shall attend an orientation to be handled by MR. FELCOR BLANCO, Education Supervisor of the Division of Misamis Occidental on May 3, 2014, 3:00 PM at Pangil Central School.
