CHANGES AND ADDITIONAL INFORMATION TO DEPED MEMORANDUM NO. 40, S. 2014 (Composition of the 2014 Palarong Pambansa National Executive Committee and Technical

Management and Administration and Designation of the Chairpersons of Various Management Working Committees)

- DepEd Memorandum No. 40, s. 2014 entitled Composition of the 2014 Palarona Pambansa National Executive Committee and Technical Management and Administration (TMA) and Designation of the Chairpersons of Various Management Working Committees has the following changes for the guidance of all concerned:
 - a. The date of the Opening Program of the 2014 Palarong Pambansa has been moved from May 4, 2014 to May 5, 2014 at 8:00 a.m. Thus, all regional delegations shall assemble for the Opening Program at their respective designated area within the Laguna Sports Complex, Sta. Cruz, Laguna as early as 5 00 a.m.;

b. The first day of the Competition shall be held on May 4 instead of

May 5, 2014; and

- c. The enclosure of said DepEd Memorandum (List of the members of the National Executive Committee, and the chairpersons of the various management working committees under the Technical Management and Administration (TMA) has been revised.
- Moreover, the following information/provision have been added for clarification:
 - a. All members of the TMA officiating officials as specified in Enclosure No. 1 are required to present the following documents upon
 - 1. Approved travel authority signed by their respective head of office:

2. Two recent 2x2 ID pictures; and

3. Medical certificate from a government physician that they are physically fit and able to serve in the Palarong Pambansa.

b. Registration and submission of documents stated in 2.a above of all technical officiating officials will be held in their respective billeting quarters as specified in Enclosure No. 4. However, members of the TMA Working Committees shall register at the Laguna Sports Complex, Sta. Cruz, Laguna.

c. The provision of DepEd Order No. 53, s. 2003 entitled *Updated Guidelines on Grant of Vacation Service Credits to Teachers* shall apply to teachers and school officials who are accredited as officiating officials or members of the different working committees.

- d. On top of the allowable expenses to be given to all members of the TMA Committees and their various management working committees per Item No. 8 of DepEd Memorandum No. 40, s. 2014, an additional amount to cover the cost of bottled mineral water is authorized, subject to the usual accounting and auditing rules and regulations.
- 3. For the four demonstration sports, namely Billiards, Futsal, Wrestling and Wushu, each delegation shall recommend one participant per event who shall undergo an on-the-job training (OJT) in managing and officiating the games. Transportation and other allowable allowances of these participants shall be charged to their respective local funds subject to the usual accounting and auditing rules and regulations.
- 4. Technical Guidelines of each sports event as stated in Enclosure No. 2 shall take effect in this year's *Palarong Pambansa* and thereafter unless otherwise revised, rescinded, or amended.
- 5. The Olympic Medal System shall be applied for this year's *Palarong Pambansa* to determine the general championship. Ranking shall be based first on the total number of gold, silver and bronze medals as stated in Enclosure No. 6.
- 6. All regions must adhere to the provisions of DepEd Order No. 40, s. 2012 entitled *DepEd Child Protection Policy*. As such, all regional delegation officials shall be held responsible for the protection, welfare, and safety of their student-athletes.
- 7. In case there is a protest, complaints should be in written form, duly signed by the coach and noted by the Head of the Delegation. Protest shall be accompanied by affidavit of witnesses and/or evidences to support thereof and shall be filed before the start of the second game of the concerned team.
- 8. Enclosed are the following documents for reference:
 - Enclosure No. 1 Revised List of the Technical Management and Administration (TMA) Committees and Officiating Officials of the Different Sports Events;
 - Enclosure No. 2 Technical Guidelines of the Different Sports Events including Demonstration Sports and Special Games;
 - Enclosure No. 3 List of Playing Venues; Enclosure No. 4 - List of Billeting Quarters,
 - Enclosure No. 5 Number of Medals to be Contested by Sports Event; and
 - Enclosure No. 6 Rules and Guidelines for the Accreditation and Screening of Athletes.

- 9. All schedules of the technical activities (Refresher Course and Solidarity Meeting) shall remain as previously scheduled.
- 10. Immediate dissemination of this Memorandum is desired.
