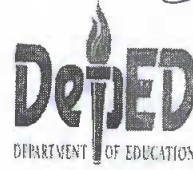

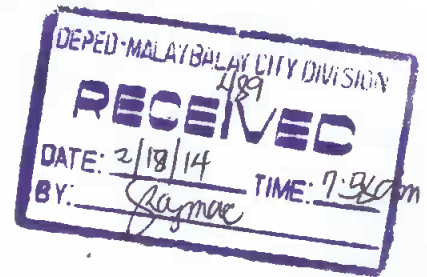

AN EXECUTIVE ORDER RECONSTITUTING THE MEMBERS OF THE LOCAL ANTI-POVERTY PLANNING CORE TEAM (LAPP Core Team) OF THE CITY OF MALAYBALAY, INCLUDING THE DESIGNATION OF CIVIL SOCIETY ORGANIZATION SIGNATORIES TO THE LOCAL POVERTY REDUCTION ACTION PLAN FOR THE ENHANCED GRASSROOTS BUDGETING PROCESS 2015

WHEREAS, pursuant to the provisions of RA 8425 otherwise known as the Social Reform and Poverty Alleviation Act which sets the policy of the State to adopt an area-based, sectoral and focused intervention to poverty alleviation , the Local Anti-Poverty Planning Core Team was created thru Executive Order No. 04, S-2012 which is responsible in the Bottom-Up Planning and Budgeting (BuPB) of priority poverty alleviation projects for 2013;

WHEREAS, the DBM-DILG-DSWD-NAPC Joint Memorandum Circular No. 3, Series of 2012, (**Policy Guidelines and Procedures in the Implementation of Bottom-Up Budgeting (BuB) for the FY 2014 Budget Preparation**) specifies the composition of the local planning team of which the members are not limited to government agencies but also to include People's Organizations, Non-Government Organizations and Civil Service Organizations (**POs/NGOs/CSOs**) operating in the area;

WHEREAS, the DBM-DILG-DSWD-NAPC Joint Memorandum Circular No. 4, Series of 2013, (**Policy Guidelines and Procedures in the Implementation of the Grassroots Participatory Budgeting Process (Formerly Called Bottom-Up Budgeting) for the FY 2015 Budget Preparation**) requires the reconstitution of the LAPP Core Team that will identify priority programs, projects and activities for FY 2015:

WHEREAS, during the **Civil Society Assembly** conducted on December 05, 2013, representatives of the different people's organization and civil society organizations selected among themselves the Co-Chair of the LAPP Core Team and the signatories to the Local Poverty Reduction Action Plan for the Grassroots Budgeting FY 2015;

NOW THEREFORE, by virtue of the power vested in me by law as the Mayor of this City, I do hereby order the reconstitution of the members of the Local Anti-Poverty Planning Core Team (LAPP Core Team) of the City of Malaybalay and hereby designate the Civil Society Organization signatories to the Local Poverty Reduction Action Plan in preparation for the Enhanced Grassroots Budgeting, FY 2015.

Section 2. FUNCTIONS AND RESPONSIBILITIES

- a. Review/Validate existing data based from surveys (MISS), situationaire from CSOs and basic sectors and existing developmental plans such as the CLUP, CDP and AIP;

- b. Formulate Local Poverty Reduction Action Plans (LPRAP) incorporating flagship priority programs, projects and activities (PPAs) for poverty reduction and incorporate these PPAs in other plans of the city;
- c. Submit to NAPC and/or to implementing agencies the approved and legitimized LPRAP in order to access resources to implement PPAs which will address poverty; and
- d. Coordinate with NAPC to ensure effective formulation, implementation and evaluation of policies, programs and resource allocations, and management of poverty alleviation programs.

Section 3. CSO SIGNATORIES

Local Poverty Reduction Action Plans (LPRAP) formulated by the LAPP Core Team shall include the signature/endorsement of the following Civil Society Organization's representatives;

Section 4. SECRETARIAT

Designated Staff from the City Planning and Development Office shall act as Secretariat of the LAPP Core Team.

This order shall take effect immediately.
