

  - Performance Rating (at least Very Satisfactory for the last three (3) (2<sup>nd</sup> Semester SY 2012-2013, 1<sup>st</sup> and 2<sup>nd</sup> Semester SY 2013-2014 or Outstanding for the last two (2) rating periods (1<sup>st</sup> and 2<sup>nd</sup> Semester SY 2013-2014);
  - Service Record
  - Certificates /Evidences of Leadership, potential and achievement;
    - a) Curriculum/instruction materials, effective teaching techniques demonstration (division level) duly certified by the Principal with attached lesson plan, attendance sheet of those witnessing the demo, and documentation;
    - b) Record of visits/observations made, teachers helped guided;
    - c) Chairmanship of special committees;
    - d) Group educational research;
    - e) In service meeting with specific topic, theme and certification of principal and supervisor;
