

2015 METROBANK-MTAP-DEPED MATH CHALLENGE

- 1. The Metrobank Foundation Inc. (MBFI), the Mathematics Teachers Association of the Philippines (MTAP) and the Department of Education (DepEd) will hold the 2015 Metrobank-MTAP-DepEd Math Challenge from January to March 2015.
- 2. The overall objective of the Competition is to contribute to the improvement of the quality of Mathematics Education in the Philippines through the following:
 - a. awakening greater interest in Mathematics among elementary pupils and secondary students in both public and private schools all over the country;
 - b. encouraging them to strive for excellence in Mathematics;
 - c. encouraging mastery of basic mathematical skills;
 - d. discovering mathematical talents among the pupils/students;
 - e. developing the values of hardwork, perseverance, honesty, teamwork, and sportsmanship; and
 - f. providing them with opportunities in leadership and cooperative undertaking.
- 3. The Elimination and Schools Division Level Competition will be participated in by elementary pupils and high school students nationwide. However, only Grade 6 pupils and Fourth Year high school students can participate in the Regional and National Finals. All public and private schools are required to submit the MMC Form No. 1 contained in Enclosure No. 4 to the Schools Division Offices (SDOs) for registration. Starting this year, the DepEd Schools Division Mathematics. Supervisor shall send the MMC Form No. 2 through an online portal. A separate Memorandum will be issued to all DepEd Schools Division Mathematics Supervisors on this innovation.
- 4. The Schools Division Mathematics Supervisors shall be in-charge of the preparation, implementation and documentation of the **Blimination and Schools Division Finals Competition** including preparation of the program and fielding of qualified officials to serve as judges, proctors, and hosts/quizmasters. He/She shall also be responsible for settling all questions, including protests, which may arise in the course of the Competition, or a panel of advisers may be formed by the Schools Division Superintendent. For security and for purpose of maintaining the confidentiality of the test questions, the turn-over of the test materials will be documented and all packages in the different stages of the Competition will be opened simultaneously at 8:00 a.m. on the date of the competition. All concerned are required

to carefully read the MMC Document No. 2 for the Operating Guidelines, as to strictly implement new policies provided in Enclosure No. 2.

- 5. For the **Regional Finals**, the Regional Mathematics Supervisor shall be incharge of the preparation, implementation and documentation of the Regional Finals, including preparation of program, designation of judges, proctors, correctors for the individual competition and hosts/quizmasters. Representatives from MTAP will assist in facilitating this stage of the individual and team competitions. He/She will also be responsible for settling all questions, including protests, which may arise in the course of the Competitions.
- 6. For the **National Pinals**, the following are the qualifications in determining the ten National Finalists for both individual and team competitions at the elementary and secondary levels:
 - Top scorers for both Categories A and B in National Capital Region (NCR):
 - b. Top scorer in each geographical area (the rest of Luzon, Visayas, and Mindanao); and
 - c. Remaining five top scorers across all regions.
- 7. All DepEd officials, including school heads and Mathematics teachers, are requested to actively campaign and enjoin support for the competitions of all public and private schools in the country to ensure maximum participation.
- 8. The participating parties shall shoulder expenses from the Elimination Round to the Regional Level Competition. Participants from private schools shall make necessary arrangements for their expenses with their respective school heads. At the national level, the Metrobank Foundation Inc. (MBFI) shall finance the transportation expenses, accommodation and meal allowance of the national finalists and their coaches. MBFI shall also provide the awards for the winners from the Schools Division Finals (medals) to the Regional and National Finals (cash prizes, medals and trophies), as well as cash incentives for the coaches of regional and national finalists.
- 9. The following documents and forms are contained in the enclosures:

In case of conflict in schedule with other DepEd activities, the schools division and regional offices are advised to assign appropriate persons to administer the tests at the schools division and regional levels on the scheduled dates. As agreed upon by the MMC National Steering Committee chaired by Undersecretary Dina Joana S. Ocampo, conduct of the contest other than the schedule below is not allowed:

February 6, 2015 (Secondary)

• Regional Finals

: February 20, 2015 (Individual

: March 13, 2015 (Individual Written Exam) March 14, 2015 (Individual and Team

- 11. Arrangements for substitute teachers must be made to ensure that the classes of the participating teacher-coaches will not be disrupted.
- 12. The Schools Division Mathematics Supervisor shall submit completion report on the conduct of the Elimination and Division Finals on or before **February 20**, **2015**. Only an electronic copy of the report should be submitted through email at mmc_secretariat@yahoo.com.
