



### PROVIDING INSTRUCTIONS TO BE FOLLOWED IN THE CONDUCT OF PUBLIC AFFAIRS

WHEREAS, public affairs require that the City Mayor, on official function, attends to official matters for the good of the constituents of the City of Malaybalay;

WHEREAS, in order not to disrupt the normal operations and activities of this office, it is necessary to designate an Officer-In-Charge;

NOW, THEREFORE, I, IGNACIO W. ZUBIRI, City Mayor of the City of Malaybalay, by virtue of the powers vested in me by law, and in order not to disrupt the normal operation of the office, do hereby designate Mr. Romeo R. Lapeciros, Jr., Executive Assistant IV in the City Mayor's Office, to do the specific functions as follows:

- 1. Attends to Mayor's callers;
- 2. Approval of local weekly travels of the City Agriculture Office, City Social Welfare and Development Office, and the Inspectorate Team;
- 3. Approve requests for the use of RP vehicles for travels within the City and Province of Bukidnon, to include Cagayan de Oro City;
- 4. Approve requests for the use of government facilities;
- 5. Approve business permits and mayor's clearances (excluding firearms clearance);
- 6. Approval of Itinerary of Travel of employees;
- 7. Approve waste materials and pre-inspection reports;
- 8. BLPO Motorela Confirmation slips.

PROVIDED HOWEVER, that Administrative Order No. <u>05</u> series of <u>2011</u> and Administrative functions delegated to Mr. Herculano s. Ronolo, will still be enforced.
