1. Pursuant to the Regional Advisory dated July 29, 2015 re: SUPERVISION OVER PUBLIC AND PRIVATE SCHOOLS. All PSDS and District OIC's are instructed to coordinate Public and Private School Administrators:
 - a. Submit the list of applicants for SBM Level of Practices Validation (Level II & III). The deadline is on or before August 28, 2015. Attention: DR. ELLEN N. DELANTE, SEPS- Monitoring and Evaluation, (SGOD).
 - b. Coordinate Private Elementary and Secondary School Owners to strictly observed the following timelines in the submission of the following applications:

1. Government Permit to Operate	August 30
2. Renewal	February 1
3. Government Recognition	January 31
4. Issuance of Special Orders	January 30
5. Tuition Fee Increase	March 30
6. Summer Class	On or before 2 nd Thursday of March
2. Private Secondary School Heads are instructed to submit the Individual NAT Result of the Test Takers (FAPE Grantees for SY 2014-2015).
3. Public School Administrators are encouraged to establish Integrated Schools to increase opportunities for Grade 7 Learners to be in schools.
4. Immediate dissemination for compliance of this advisory is enjoined.



SUBJECT	SUPERVISION OVER PUBLIC AND PRIVATE SCHOOLS

To facilitate the direct supervision over Public and Private Schools by the division office, compliance to the herewith requirements is hereby required:

- a. Submit the List of Applicant Schools for SBM Level of Practices Validation (Level II & III). Deadline for submission will be on September 4, 2015. It is expected that the 1.5 cut-off score in the Performance Indicators (Part I of the Assessment Tool) after the Total Score is multiplied by 60% to qualify for endorsement to this Office will still be observed.
- b. Through that Office, please communicate to the Private School owners to observe the Timelines in the submission of application:
 1. Government Permit to Operate -August 30
 2. Renewal -February 1
 3. Government Recognition -January 31
 4. Issuance of Special Orders -January 30
 5. Tuition Fee Increase -March 30
 6. Summer Class -on or before 2nd Thursday of March
- c. Private Schools are encouraged to submit the Individual NAT Result of the Test Takers (FAPE grantees for SY 2014 – 2015)
- d. Establishment of Integrated Schools to increase opportunities for Grades 7 learners to be in school.
