



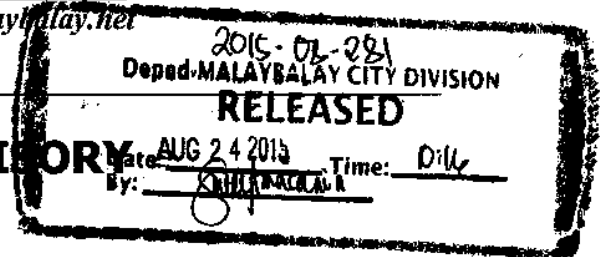

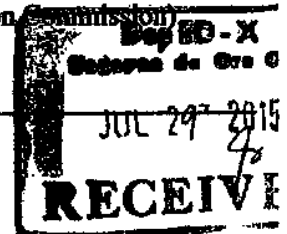

The Philippine Guidance and Counseling Association Region X Chapter (PGCA X) will be holding its 10<sup>th</sup> Regional Convention and Seminar Workshop on September 3-4, 2015 at N Hotel, Kauswagan, Cagayan de Oro City. It will carry this year's national theme "Evidence-Based Counseling: Current Directions, Practices, and Challenges".

The 2-day convention will include the keynote address, research paper presentations, and three workshops on the current trends and practices of guidance and counseling. Dr. Evangeline P. Aguilan, RGC, RP, RPrm - PGCA National President will be keynote speaker and workshop facilitator on the 1<sup>st</sup> day of the convention. Two successive workshops on competency-based topics are scheduled on the 2<sup>nd</sup> day to be facilitated by counseling practitioners from the tertiary and basic education.

Attached is a copy of the tentative program. Attendance to this 2-day convention will gain points for the Continuing Professional Education (CPE) necessary for the renewal of the Counselor's Professional License. We are cordially inviting Registered Guidance Counselors, Administrators, newly appointed Guidance staff, and students in Guidance and Counseling to attend.

To avail of the discounted rate in the registration fee, we strongly recommend that you pre-register as early bird.
