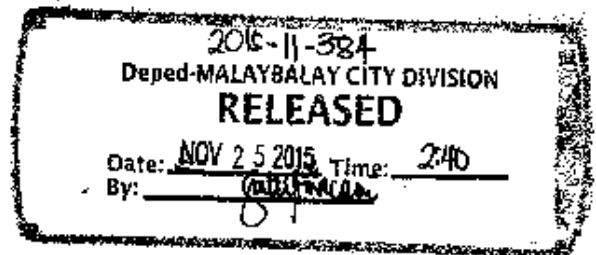






**Dear ESC/NON-ESC PRIVATE JUNIOR HIGH SCHOOL,**

Warm Greetings from the PEAC National Secretariat!

The national roll-out of Senior High School (SHS) in SY 2016-2017 is fast approaching. We are directing you to the recent issuance of DepEd Order No. 46 s. 2015 that covers the guidelines for the SHS Voucher Program (SHS VP) that is expected to provide assistance to qualified voucher recipients such as Junior High School ESC completers of SY 2015-2016 who intend to pursue SHS in a Non-DepEd SHS provider (a private SHS school, State University or College, Local University or College, or a Technical Vocation Institution) – all of which, must have secured a permit from DepEd to offer SHS. The said DepEd Order may be viewed/downloaded from the PEAC website at [www.fape.org.ph](http://www.fape.org.ph) or in the DepEd website at [www.deped.gov.ph](http://www.deped.gov.ph).

While the actual orientation on the SHS VP guidelines will be conducted alongside the schedules of the ESC guidelines in April to May of next year, your awareness of the guidelines this early will help familiarize you with how the program will run, the voucher values, the automatically qualified beneficiaries and the process of application for those not automatically covered by the vouchers. More importantly however, we are prompting schools to take action on some items that must be done as early as October 2015, as follows:

**A. For JHS ESC Grantee Completers of SY 2015-2016**

Your school must inform them and their parent/guardians not later than the first week of November 2015 of the following:

1. They are qualified voucher recipients (QVRs) for 80% of the applicable voucher value if they decide to apply and are accepted in a Non-DepEd SHS provider.
2. The school must encourage these grantees to start registering in a Non-DepEd SHS provider of their choice as early as October 2015 to facilitate the processing of their eventual enrolment in the chosen Non-DepEd SHS provider.
3. The grantees may choose from any among the Non-DepEd SHS providers approved by DepEd in a list that may be viewed/downloaded from the DepEd website.



**B. For SY 2015-2016 JHS Completers (non-ESC) of Private ESC Schools and Non-ESC Private Schools**

Your school must inform them and their parent/guardians not later than the first week of November 2015 of the following:

1. They are not automatically qualified under the voucher program.
2. They have the option to apply for a voucher, as follows:

Application for vouchers through a Voucher Application Form -1 (VAF-1) shall commence on the second Monday of November 2015 and end depending on the type of application process the voucher applicants uses, as follows:

**Online Submission** – VAF-1 deadline is on February 12, 2016. Access is through the Online Voucher Application Portal (OVAP) at: [ovap.deped.gov.ph](http://ovap.deped.gov.ph)

**Manual Submission** – VAF – 1 deadline is on January 15, 2016. VAF-1 is available in DepEd Division Offices, JHSs and Non-DepEd SHS providers, a copy may also be downloaded from the PEAC website.

The results of voucher applications shall be emailed directly to applicants on the 3<sup>rd</sup> week of March 2016. Results may also be viewed through the OVAP.

**C. For Non-DepEd SHS Providers**

Non-DepEd SHS providers are those that have secured a permit from DepEd to offer SHS and are officially listed in the DepEd website as well as in the PEAC website.

1. Non DepEd SHS providers are encouraged to conduct an annual early registration of QVRs as early as October 2015 to coincide with the early registration of DepEd

Senior High Schools to provide them equal opportunity to access and market to would-be SHS students.
