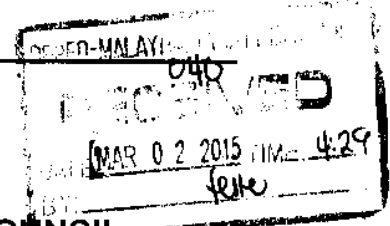

**RECONSTITUTING THE CITY ANTI-DRUG ABUSE COUNCIL
(CADAC)**

WHEREAS, Section 16 of the Local Government Code of 1991 provides that local government units shall pursue undertakings to improve public morals and maintain peace and order among other significant concerns;

WHEREAS, drug abuse continues to cause havoc on individuals, and families in our locality and its harmful effects spreading throughout our locality, thus, there is an urgent need to reconstitute the membership of this Committee;

NOW THEREFORE, I, IGNACIO W. ZUBIRI, Mayor of the City of Malaybalay, by virtue of the power vested in me by law, do hereby order the reconstitution of the membership of the City Anti-Drug Abuse Council to be composed of the following:

SECTION 1. Composition:

SECTION 2. Roles and Responsibilities. The City Anti-Drug Abuse Council shall have the following roles and responsibilities:

1. Serve as a focal point through which various organizations and individuals work together cooperatively in the planning, implementation and evaluation of programs on drug abuse prevention;

1. Serve as a focal point through which various organizations and individuals work together cooperatively in the planning, implementation and evaluation of programs on drug abuse prevention;
2. Provide for an effective mechanism for the coordination of existing services and programs and those which might be developed in the immediate future;
3. Provide for a mechanism to obtain funds, volunteers, facilities and technical expertise; and
4. Perform other related responsibilities as may be assigned by competent authorities.


SECTION 3. *Secretariat.* The Community Affairs Division of the Office of the City Mayor shall serve as secretariat to the council.

SECTION 4. *Meetings.* The City Anti-Drug Abuse Council shall conduct quarterly meetings and special meetings. Minutes of said meetings shall be prepared by the Secretariat duly signed by the attendees with the corresponding attendance sheet attached to the minutes.

SECTION 5. All orders and issuances, or parts thereof, which are inconsistent with this Executive Order are hereby repealed or modified accordingly.

This order shall take effect immediately upon my approval.
