## DIVISION TRAINING WORKSHOP ON CONTEXTUALIZATION OF KINDERGARTEN TEACHERS' GUIDE

To: **Education Program Supervisors** Public Schools District Supervisor (Districts 1, 2, 7, 8, & 10) School Heads (of schools serving IP communities) This Division

- Pursuant to DepEd Order No. 62, s. 2011 and DepEd Order No. 32, s. 2015 on Indigenous Peoples' Education Policy & Curriculum Framework, the Division of Malaybalay City will conduct a Division Training Workshop on Contextualization of Teachers' Guide for schools serving IP communities at Loiza's, Casisang, Malaybalay City on September 9-11,2015.
- The activity will serve as forum for teachers and school heads to work on contextualizing the kindergarten learning guide to attain a culture-responsive and culture-sensitive education for the indigenous learners and to be oriented on DepEd Order No. 32, s. 2015 re Indigenous Peoples Education Curriculum Framework as well as reorientation on DepEd Order No. 62 s. 2011 known as the Indigenous Peoples' Education Policy Framework, and DepEd Order No. 51 re Guidelines on the Conduct of Activities and Use of Materials Involving aspects on IP Culture.
- Participants of the training workshop are the school heads and one Kindergarten teacher who speaks Binukid language from each of the following schools: Baganao ES, Bangcud CS, Caburacanan ES, Can-ayan IS, Candiisan ES, Dalwangan ES, Kalasungay CS, Kapitan Angel ES, Kibalabag ES (N), Kilap-agan ES, Kulaman ES, Linabo CS, Manalog ES, Mapulo ES, Patpat ES, St. Peter ES, Silae ES, Tag-ilanao ES, & Tintinaan ES; NCIP; Division Office TWG, PSDS (Districts 1,2,7,8, & 10); & Support Staff. If the kindergarten teacher is a non-speaker of the language, the school IP coordinator may be sent to participate in the workshop.
- All teacher-participants are required to bring their National Kindergarten Curriculum Guide (NKCG) and laptop with extension wire.
- Meals and materials for the training and compensatory allowance with lodging for the resource persons will be charged to IPEd Funds while transportation expenses will be charged to local/school funds subject to usual accounting and auditing rules and regulations.
