SUBMISSION OF REQUIREMENTS FOR THE ISSUANCE OF SCHOOL SITE SPECIAL PATENT

- In line with the DepEd Memoranda No's. 28 and 31, series 2015 and pursuant to Department of Environment and Natural Resources (DENR) Administrative Order No. 2015_01 dated March 04, 2015 entitled Guidelines for the Processing and Issuance of Special Patents, Public School Heads are directed to submit the following requirements:
 - a. Accomplished Request Form of the Schools Division Superintendent (SDS) or Authorized Official from the DepEd Central Office for the issuance of Special Patent
 - b. Historical background of possession or occupation.
 - Recent photographs showing the panoramic view of the sea, as well as adjacent areas, vicinity improvements introduced, buildings, landmarks, identifying features, settlements, if any;
 - d. Certification of no pending land registration case application over the proposed area issued by the Regional Trial Court (RTC) or Land Registration Authority (LRA) having jurisdiction over the Land.
- The list of schools qualified for the issuance of special patents is enclosed. School Heads
 must submit certified true copies and Two (2) photocopies of the above-enumerated
 requirements to this office on or before September 30, 2015.
