## DIVISION TRAINING WORKSHOP ON CONTEXTUALIZING OF CURRICULUM FOR KINDERGARTEN AND GRADE ONE

- To: Education Program Supervisors, CID & SGOD Chiefs and Staff Public Schools District Supervisors (Districts 1, 2, 7, 8, & 10) School Heads (of schools serving IP communities) This Division
- 1. Pursuant to DepEd Order No. 62, s. 2011 and Deped Order No. 32, s. 2015 on Indigenous Peoples' Education Policy & Curriculum Framework, the Division of Malaybalay City will conduct a Division Training Workshop on Contextualizing of Curriculum for Kindergarten and Grade One at Loiza's, Casisang, Malaybalay City on November 23-25, 2015.
- 2. At the end of the training workshop, participants are expected to develop a holistic perspective on the overall learning and socio-cultural context of indigenous communities. I particular, participants are expected to:
  - a. walk through the competencies towards the contextualization of the curriculum responsive to indigenous community being served;
  - b. develop lesson plans based on the contextualized curriculum for IP education; and
  - produce school based lesson plans reflecting a culture-responsive and culturesensitive education for the Indigenous learners.
- 3. Resource persons and consultants on the language and the IKSPs are the IP elders considered as culture bearers of the Bukidnon and Higaonon tribes.
- 4. Facilitators of the activity are school heads and teachers who attended the Regional TOT, namely: Dr. Manny Pimentel, Narita Padua, Teofilo Ontoy, Amor Rojas, Sonny Rojas, Mary Fe Gumayao, Dr. Jesus Muring, and Raquel Ombayan.
- 3. Participants of the training workshop are the select school heads and select Kindergarten grade one teachers who speak Binukid/Higaonon language from schools serving IP communities, NCIP, Division Office TWG, & Support Staff.
