

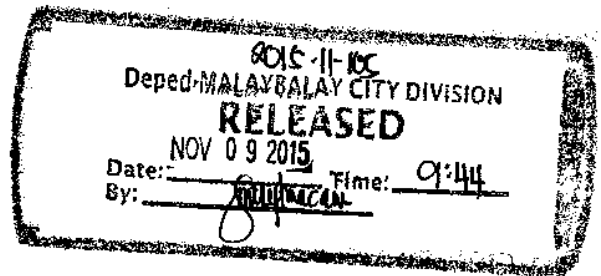

Subject: CONDUCT OF SENIOR HIGH SCHOOL EARLY REGISTRATION

Date: November 5, 2015

1. Pursuant to DepEd Order No. 46, s. 2015 entitled Amendment to DepEd Order No. 41, s. 2015 (Senior High School Career Guidance Program and Early Registration), this Office reminds the Schools Division Offices and Senior High Schools to observe the following during the conduct of SHS Early Registration on November 9-13, 2015 :
 - a. to ensure participation of the Non-DepEd Providers;
 - b. to cater to Grade 10 students enrolled in private schools;
 - c. to provide equal opportunity to high school graduates prior to the full implementation of the K to 12 Program, passers of the Philippine Educational Placement Test (PEPT) and Accreditation and Equivalency (A & E) for JHS Level, and other learners outside the formal system who opt to pursue Senior High School.
2. The Schools Division Offices shall submit a Consolidated Report on the Number of Early Registrants by Track and by Strand from both DepEd and Non-DepEd Providers which also specifies the:
 - i. number of learners outside the formal school system and
 - ii. number of registrants/students who are graduates prior to the full implementation of the K to 12 Program) on or before November 17, 2015 thru the Regional Senior High School Coordinator thru email address ninian16@yahoo.com.
3. This Office also encourages the Schools Division Offices and Senior High Schools to visit the official Facebook account Region 10 – SHS Program implementation for information and updates.
