1. Pursuant to DepED Memorandum No. 293, s. 2007 re: Implementation of School Gulayan Sa Paaralan, this Office will conduct Division Level Search for Best Implementing schools in Gulayan sa Paaralan at Gulayan sa Tahanan Projects both in elementary and secondary on November 12, 13 and 15, 2015 respectively.
