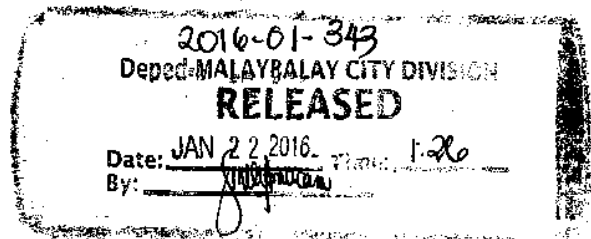

**AN EXECUTIVE ORDER LIFTING THE MORATORIUM ON THE EXPANSION OF EXISTING COMMERCIAL POULTRY AND PIGGERY ESTABLISHMENTS IN THE CITY OF MALAYBALAY IMPOSED UNDER EXECUTIVE ORDER NO. 19, S. 2013**

WHEREAS, the undersigned, pursuant to the general welfare clause of the Local Government Code of 1991 (R.A. 7160), issued Executive Order No. 19, s. 2013, on September 30, 2013, imposing moratorium on the expansion of existing commercial poultry and piggery establishments in the City of Malaybalay due to the reported presence of avian disease as reported by concerned poultry and piggery operators;

WHEREAS, the imposition of the moratorium was made as a necessary precautionary measure to ensure the prevention of the spread and/or outbreak of the said disease among local poultry and piggery industry in the City of Malaybalay;

WHEREAS, it has now been determined that presently there is no more threat of such nature to the local poultry and piggery industry in the City of Malaybalay;

NOW, THEREFORE, I, IGNACIO W. ZUBIRI, City Mayor of Malaybalay City, by the power vested unto me by law, hereby order the **LIFTING** of the moratorium on the expansion of commercial poultry and piggery establishments in the City of Malaybalay as imposed under E.O. No. 19, s. 2013.

This Order shall take effect immediately.
